Educational items for students to own

Boronia K-12 College have a BYOD laptop program from Years 5-12. Students are encouraged to bring their own device. Further information regarding the laptop program is available on compass.

Extra-Curricular Items and Activities

Boronia K-12 College offers a range of items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides in order to deliver the Curriculum. These are provided on a user-pays basis. Details of these items and activities will be provided to students and families throughout the year.

Vocational Educational Training (VET)

From 2022 the Department will reimburse VET material fees to government schools to address the cost barrier for families. This funding covers the costs of:

- Materials required for training and assessment that are consumed and cannot be recycled. Please note students may wish to upgrade materials for certain projects (i.e., upgrade from pine to mahogany). **Any upgrade to materials provided by Boronia K-12 College is considered to be an OPTIONAL ITEM.**
- Workbooks, handouts, photocopying
- Class sets, intended to be returned where ownership does not pass to the student *i.e.*, aprons, tools

However, this funding does not cover all costs associated with the facilitation of VET classes. The payment of the following costs is supported by Voluntary Financial Contributions from families, as detailed in the Voluntary Financial contributions schedule above:

- Online registration/subscription fees
- Tuition fees, registration and administration fees

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VPC.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
